The main speakers talked about the following aspects relating to consumer awareness,

- The Consumer Protection Bill, 1986.

- The bill received the assent of the President on December 24, 1986, and came into force.
- Thus, to commemorate the importance of the day, December 24 is marked as National Consumer Day.
- The Consumer Protection Act aims to provide consumers with effective safeguards against different types of exploitation such as defective goods, deficiency in services and unfair trade practices.
- To provide speedy and simple redressal to consumer, a quasi - judicial machinery is sought to be set up at the district, State & Central level.

Prizes were distributed by the chief guest to the student speakers. It was followed by a few students' speeches and then vote of thanks was proposed by A. Pavani III B.com (GEN) and the programme was concluded with National Anthem.




